Minutes of Monthly Membership Meeting February 9, 2012

Minutes of previous meeting: Approved as amended.

Membership: Deferred.

Presidents Report: Legislative Season is in full swing. I have been down at the halls of the Legislature, representing HPMA, both on opening day, and in hearings. The results of the APA National Elections will be made public in a few weeks. AMA is coming to Honolulu in November. Planning for a welcome reception for the AMA Board of Trustees and certain specialty society delegates, as well as elected Hawaii Officials, has begun. APA, HPMA, and HMA will host, and the Hawaii Convention Center will sponsor.

Treasurer Report (Dr. Sakuda): Current balance is \$45,165.55, as we are now in receipt of the CALF grant. Dr. Sakuda agreed to draft a budget for calendar 2012.

Ethics Report: (Dr. Prier): No ethics issues reported this month.

Legislative Report: Legislature opened January 18, 2012.

Telepsychiatry (HB 1708): Representative Evans submitted legislation to permit initial involuntary hospitalization exam by telemedicine. It passed House Health and this week passed Judiciary first reading with amendments.

Single Prior Authorization Form (HB 1741): Dr. Akaka testified in support.

Crash Course Prescribing: HPMA will continue to vigorously oppose any legislation that seeks to legitimize crash course prescribing while supporting legislation that improves access to safe medical care. As of now, no new bills have been submitted, and only a resurrection of the bill from last year could be heard by the Legislature.

Communication Report: Deferred.

Reimbursement committee (Dr. Doug Smith): Deferred.

Membership Committee Report: Dr. Leslie Gise has accepted appointment as Chair of the Membership committee for the duration of Dr. Akaka's term.

New Business:

Business Cards: discussion held and agreed that new business cards for Dr. Akaka will be purchased.

Continuing Medical Education: Deferred for now, but if there is future interest the HPMA could put together a program.

Elections: An election slate is needed for new officers for an April election.
