Dr. Kemble was appointed by Governor Abercrombie to the Hawaii Health Authority, charged with overall health planning for the state and with designing and running a universal health care system covering everyone in Hawaii. He is also the incoming President ot Hawaii Medical Association. He gave out handouts, copies of which could be made available if requested
