Minutes of previous meeting: reviewed and approved.

BUDGET & COMMITTEE REPORTS:

- Ethics Committee Report: per Dr. Prier no recent referrals or concerns.
- Legislative Committee Report:
 - legislature ended; telemedicine senate bill was introduced by Rep. Mark Takai as part of National Guard to increase access of mental health care on neighboring islands; providers would have been credentialed by Tripler; passed house and senate

• Membership Committee Report:

- o As of 3/2013, we have 174 members
- Increase neighbor island membership involvement:
 - Dr. Donna Ching, rep for the Big Island?
 - Dr. Stephanie Skow, agreed to be the representative for Kauai; can also do a get-together to reach out to psychiatrists and members there; they currently try to meet up on the 2nd Tues of every month for lunch
- Maui get-together on 5/8/13: 9 psychiatristrists were there
 - 2nd time event; prefers to have Oahu representation
 - discussed benefits of HPMA
 - reached out to MDs who were not members
 - send receipts to Dr. Ahmed for reimbursement
 - possible rep for Maui: Micheline Dugue who works at VA; Amber and Leslie to f/u.

• Communications: Dr. Suzuki:

- Will split up membership list to remind members to renew membership; Leslie advised people to not call the lapsed member more than 3 times
- There is a membership payment plan available via credit card and paying in installments. Remind members that if it weren't for the APA, reimbursement rates via CPT coding wouldn't have passed
- o will post on HPMA website re: CPT parity abuses by insurance companies
- o will solicit more blog articles and maintain Twitter and Facebook accounts

- Clarified that APA Grant \$ will be used to fund lobbyist
- Budget report
- Area 7 Council Mtg, New Mexico: Dr. Ahmed, deputy rep.
 - o Paul Summergrad, MD, newly elected president of the APA
 - in New Mexico, where psychologists can prescribe, they are trying to push for more independence
 - New Mexico psychiatrists are suggesting that any new legislation regarding this topic should be presented to an advisory review committee rather than to legislators
 - Sunshine Bill in AZ: any new bills have to be reported before they're submitted
 - o ACA and health exchanges coming, Hawaii included
 - Kaiser Family Foundation website http://www.kff.org/ has updates on every single state regarding the upcoming health exchanges
 - Some states are trying to legalize medical marijuana
 - o gun control legislation hot topic
 - o there are concerns about member apathy in a number of states
 - o CME is an important activity in some states: Nevada using it to raise revenue
 - Loss of ECP members; ECP committee looking for suggestions on how to increase ECP membership
 - There was some discussion of term limits for assembly legislative rep and about electing an ECP to become the deputy rep, while grooming them to later become the legislative rep
