BUDGET & COMMITTEE REPORTS:

- **Treasurer's Report:** Dr. Aulwes we got the CALF grant for 2014 utilization for legislation purposes; thank you to Drs. Ahmed, Akaka, and Murayama-Sung for their hard work on the grant application
 - Overall budget: we're still in the black ☺
- Ethics Committee Report: Dr. Prier to research APA ethics regulations regarding member's professional status before accepting them into a district branch as a member
 - Remember, all ethics complaints must be submitted in writing to the HPMA president
- Legislative Committee Report: Dr. Akaka our lobbyist Bobby Toyofuku has requested to meet with members interested in legislative matters to start planning for the next legislative season which starts 1/2014
- Membership Committee Report: no updates
- **Communications:** Dr. Suzuki we're still awaiting the final results of the District Branch Innovative Grant submission
 - Dr. Ahmed participated in a MHA Brown Bag Lunch session at Central Union Church in 11/2013

- Dr. Ahmed was interviewed by Medscape regarding medical services utilization in the elderly in 11/2013
- United Self Help at the Waikiki Health Center is always interested in having volunteer psychiatrists participate in their Q&A forums; contact Bud Bowles if interested
- ECP report: Dr. Lee no updates
- Assembly and Board Reports: Dr. Akaka Board of Trustees mtg was held 12/7-12/8 in NYC
 - Present APA CEO Saul Levin was present and things appear to be moving fast and his goals include the following:
 - Communications audit within the APA; reviewing all media coverage from 10/2012-10/2013 regarding membership and research
 - Website needs to be user-friendly; currently a lot of data but doesn't have a unifying message/brand
 - Develop "best in class" in communication
 - Digital channel analysis
 - Organization audit: interviewed all leadership members and discussing "here is where you want to go"
 - Opportunities for improving APA: have a uniform look/brand for modern psychiatry; perhaps changing our logo/symbol of Benjamin Rush?
 - Because there is no single recognized leader in mental healthcare, this is an opportunity for APA to become the expert in the field
 - Define the audience
 - Staff needs to be empowered to be "brand ambassadors" of APA

Old Business:

- Neighbor island DSM-V trainings: Drs. Sakuda and Ahmed to f/u with Kauai rep Dr. Stephanie Skow, Big Island rep Dr. Donna Ching, Maui rep Dr. Micheline Dugue 917-660-2505 to see if there is any interest in DSM-V trainings on their island; HPMA members will be free of charge and non-members will have a small attendance fee
 - We have a \$2500 grant to do trainings

New Business:

- Mental health parity law update: "final rule" is the final rule per Dr. Akaka
 - Parity law was passed 3 years ago but it's still not really finalized yet
 - APA needs patients who are willing to come forward to report how they've been harmed by not having access to mental healthcare coverage through their medical insurance coverage; send complaints to Sam Musinski of the APA
- Dr, Ahmed brought to our attention an article in the NYTimes recently regarding psychiatrists being the physician specialty group to least likely take Medicaid/Medicare patients; Dr. Prier reports there's also an article in Medscape on this issue
